The NCSFA acknowledges and celebrates the many diverse talents of our members with a traveling exhibit this year that begins in the Escondido Expressions Gallery and ends at the PCPA. This is not a juried show, and members are encouraged to submit 2 artworks for the show at the Expressions Gallery and an extra piece for the Poway exhibit. Members will be responsible for transporting/picking up their work at each venue.

REQUIREMENTS/INFORMATION

All 2D media will be accepted

Entry Limit: One or two artworks may be submitted by each artist for the Expressions Exhibit, and additional piece for the PCPA Exhibit. This is a total of three pieces in the PCPA Exhibit, which includes the two from the Expressions Exhibit (unless sold) and the additional piece for the PCPA.

Fees: \$40 for one or two artworks at both the Expressions Exhibit and PCPA, and \$10 more if you wish to show a third piece at the PCPA Exhibit.

Awards: The combined exhibit awards will be presented at the PCPA reception on Saturday, December 1st. The awards will be \$100 First place, \$75 Second place, \$50 Third place, and for the Expressions exhibit, a \$35 award will be given for a People's Choice. Honorable Mention certificates to be awarded at the discretion of the juror.

Commission: For works sold at the Expressions Exhibit, a 10% commission is payable to the Escondido Arts Partnership. At the PCPA exhibit, artists agree to pay 15% of gross revenue for sale of artwork to the City of Poway, plus sales tax. Sharon Ford SharnnPaul@gmail.com will be the contact for sales. NCSFA does not charge additional commission for work sold.

Size Limit: Expressions exhibit: No piece smaller than 12", or larger than 32" on any side, FRAME INCLUDED. PCPA: An additional piece for the PCPA exhibit may be no larger than 48" on one side.

Framing: Works must be framed, wired, and ready to hang. No saw-tooth hangers. Exception: works on canvas do not need a frame if the stretcher uses a wrapped canvas with no staples showing. For wood frames use D rings with an opening of at least ¼", positioned on the vertical sides of the frame from 1 ½ to 2" from the top. For metal frames, move the vertical slide pieces to the top of the channel.
